Write-up:

A write up of between **200 and 250 words is required for the catalogue entry**. Please include this separately via email. Examples of past write-ups can be seen in the archive results on the website (www.auctionofthestars.com). If you would like assistance with your write-up please contact AOS before the closing date of entries.

This should include comment on paces, temperament, conformation, performance highlights of parents or close relatives, the field in which the horse is likely to excel, what is the likely buyer market, e.g. all-rounder, professional, specific Olympic discipline, etc.

Photos:

At least **three, side on, high resolution photographs** are required of the horse (at least 1MB). The horse is expected to be presented well in the photos, plaited, with a neat backdrop and a well-presented handler or the rider to be in competition dress with white jods, competition shirt and jacket. Photos may be rejected if they are not of high enough standard.

Video:

A short video of the horse free schooling or under saddle is required. Again the horse and handler/rider must be well-presented as required for the photos.

Please note: many buyers will purchase horses, especially youngsters, on the basis of photographs and footage. Vendors in the past have found that supplying a professional photograph and top-quality video footage is very worthwhile.

A certificate of good health is required to be completed on the horse within 2 weeks prior to the Auction. A copy of the compulsory certificate of good health from a veterinarian must be handed in to the auction office prior to the auction. This is necessary for insurance and legal purposes.

- Nominated a reserve price at the time of entry.
- Booked a vet for the required certificate of good health as stated in #11 in the conditions of entry.
- Ensured that you have a long-sleeved white shirt/shirts to wear at the auction.

Conditions of Entry:

1. Each horse must have a signed nomination form sent to AOS by the nominated date.
2. A cataloguing fee of \$748 (inc GST) plus a minimum of one night's stabling must accompany entry and will be refunded if the horse is not accepted. All sales incur 10% GST, unless not GST registered.

See OWNER INFORMATION re GST above.

3. All the horses accepted for the auction must be at the auction venue by the morning of the day PRIOR to the day of the auction (Saturday). Signage will be provided for each stable door to help buyers identify auction lots.
4. All horses remain at risk of the vendor in respect of any damage or injury until the horse has been sold. Neither Auction of the Stars nor the owner/manager of the auction venue shall accept any responsibility for any claims, losses, suits or damages made against or suffered by them by reason of any negligent act or omission on the part of any rider, trainer or attendant whilst he is attending or otherwise handling a horse.
5. Upon sale of the horse the auctioneer will take 10% commission + GST.
6. Final selection of the auction horses will be driven by commercial considerations.
7. The entries of the highest standard, in the opinion of the directors, will initially receive priority.
8. The reserve price will be evaluated and any entry with an unrealistically high reserve is unlikely to be accepted. *Please note:* if an entry is accepted and the reserve is exceeded at auction but the vendor changes their mind and decides to increase the reserve (or not sell), the vendor will be charged 10% commission plus GST on the passed in price by Auction of the Stars whether the horse is sold or not.

10. A copy of all documents required for the transfer of ownership – registration papers, pedigree papers – must accompany the nomination form.
- 11. A copy of the compulsory certificate of good health from a veterinarian must be handed in to the auction office prior to the auction. This is necessary for insurance and legal purposes.**
12. The auction catalogue will be available on the website approximately 6 weeks before the auction date and will be widely distributed to thousands of email addresses nationally and internationally.
13. The vendor of any horse that does not present to the auction will be charged 10% of the above nominated reserve price plus GST unless a vet certificate is produced to excuse its absence.
14. Once accepted, no horse may be sold prior to auction. The auction is not to be a collection of equestrian leftovers but an elite presentation of horses!
15. The vendor of any horse sold within a 45-day period post-auction to any buyer or during the next three months to a bidder from the auction or to a buyer introduced to the vendor by AOS, will be liable to pay 10% of its sale price to Auction of the Stars.
16. Auction of the Stars undertakes to further advertise any horses that may be passed in at the auction on its website at www.auctionofthestars.com for a period of three months post-auction.
17. Any previous operations, ongoing medical conditions or genetic faults (eg parrot mouth) must be declared on this application form although these do not necessarily preclude the horse from being accepted.
18. Each vendor is required to take out an appropriate colour ad in HORSE DEALS in the chosen issue as surveys show that potential buyers do align their interest with a selected horse before the auction. These ads will be run under the Auction of the Stars banner for maximum effect. They are organised by Auction of the Stars and will not be larger than a quarter page. You will be contacted by HORSE DEALS for individual payment.
19. Each vendor must supply a side-on high resolution photograph of the horse via email. Entries cannot be accepted if the photograph is not a high resolution photograph.
20. Horses must arrive at the auction accompanied by their registration papers and if sold, the horse's papers will be posted to the new owners once all payments have been received and cleared for the particular horse.
21. The vendor agrees to present their horse on the day of the auction in Auction of the Stars uniform as provided by Auction of the Stars. Please note that AOS has a number of sponsors, which all vendors will support by wearing supplied uniforms (jacket or vest, cap, saddlecloth). Please would you bring a long sleeved white shirt to the auction. In extenuating circumstances where vendor sponsors are in conflict with Auction of the Stars sponsors, a vendor may be given special consideration for exemption from AOS uniform. That decision will be made by AOS directors. There will be no private sponsorship advertising.
